Pursuant to §103D-102(b)(4), HRS, and Chapter 3-120, HAR, the Department requests a procurement exemption to purchase the following:

Tuberculosis Drugs

8. Explanation describing how procurement by competitive means is either not practicable or not advantageous to the State:
On November 4, 1992 the Veterans Health Care Act was signed into law as P.L. 102-585. A new section in the Act creates a program wherein drug manufacturers must provide statutory discounts for covered outpatient drugs to agencies receiving grant funds related to treatment of tuberculosis through a state or local government. The State of Hawaii's Tuberculosis Program is a participant. Tuberculosis drugs under this Act are discounted with prices that cannot be matched by non-participating drug manufacturers. The results are cost effective to the TB program's operations.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable:
Vendor(s) to be selected from drug manufacturers providing statutory discounts.
Program to follow State's procurement code delineated under section 3-120-4. Procurement exempt from Chapter 103D HRS. Exclusion from Veteran Health Care Act would compel program to meet small purchase requirements for amounts less than threshold levels and be subject to competitive bidding for amounts equal to or greater than threshold.

10. A description of the agency's internal controls and approval requirements for the exempted procurement:
Medications are distributed based on program's Physicians' written order, based on their examination and review of patient diagnostic tests and/or x-ray. Any other medication required for patient treatment and not on attached listing would be purchased via state procurement policies and procedures.


