Pursuant to §103D-102(b)(4), HRS, and Chapter 3-120, HAR, the Department requests a procurement exemption to purchase the following:

3. Description of goods, services or construction:

The purpose of the grant and MOA is to evaluate a biopower system and to conduct an agricultural business plan competition. Both initiatives are in-line with the legislative intent of Act 73 (Session Laws of Hawaii 2010; "Act 73(10)") and the purposes of the Hawaii Economic Development Task Force.

8. Explanation describing how procurement by competitive means is either not practicable or not advantageous to the State:

There are no other county-level Economic Development Boards specific to the County in which to seek competitive procurement from; and therefore is not practicable or advantageous of the State to pursue. Also, the proposed grants to the Economic Development Boards are perscribed by Act 73(10) and specific to energy and food security issues.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable:

The vendor has been selected based on legislative mandate to provide grants to the County 'Economic Development Boards' as perscribed by Act 73(10) (p. 10, Section 3(b)(3), lines 1-7); as follows: "grants-in-aid to the economic development boards of each county." These Economic Development Boards also are identifiable representatives of the Hawaii Economic Development Task Force mandated by the Legislature.

REQUEST FOR EXEMPTION FROM CHAPTER 103D, HRS (Cont.)

10. A description of the agency's internal controls and approval requirements for the exempted procurement:
 The procurement was reviewed by the SID Contracts Office, then routed to the SID Administrator for approval. It was then routed to the DBEDT Director for approval. Director approved on 4/19/11, and a "Request for Approval to Expend Appropriated Energy Security Special Funds via Grants to the County Economic Development Boards" was routed to B&F. The request for Governor's approval thru B&F was deemed not necessary per B&F. B&F felt the MOA's nature of the services, which DBEDT would be entering into with the EDBs were not consultative or personnel services. SID'S understanding of the EDB grants per Act 73(10) and Chap. 42F is that the EDB grants are defined in 42F-101 and grants were appropriated by the Legislature to specific recipients (County EDBs). However, at the recommendation of DBEDT's ASO, SID seeks the approval of the CPO for this exemption request.
