Pursuant to HRS § 103D-102(b)(4) and HAR chapter 3-120, the Department requests a procurement exemption for the following:

1. Describe the goods, services or construction:

Waimanalo Health Center would relocate the current WIC clinic from the main building to a new renovated Building F to service WIC participants. This new space would more than double the size of the current WIC space and would include private offices, private work areas, private area for health assessments, an education-demo kitchen, and a conference room. The renovation would also include ADA compliant ramps and restrooms to more efficiently serve the WIC participants. The renovation would increase client confidentiality and strengthen nutrition education and breastfeeding support goals of the WIC Program.

6. Explain in detail, why it is not practicable or not advantageous for the department to procure by competitive means:

Availability of Operational Adjustment funds by the United States Department of Agriculture Western Region office was limited to WIC State Agency and current Chapter 103F Purchase of Service (POS) WIC Providers only for enhancement of WIC services to participants in the state. A Legal Ad for the Request for Information (RFI) was posted to SPO's Procurement Notices Website on September 16, 2011.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

In response to the RFI, a request for Operational Adjustment funds has been submitted by Waimanalo Health Center. This request has been forwarded by the WIC Services Branch to the United States Department of Agriculture Western Region office for their evaluation and approval for funding.
