6. Explain in detail, why it is not practicable or not advantageous for the department to procure by competitive means:  
The Correction Division is standardizing the radio equipment system within its facilities to Motorola equipment compliant to the P25 standard. While there are other P25 compliant equipment, the parts to the equipment are not compatible. The standardization of equipment will enable the Corrections division to be pro-active in maintaining and replacing items.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:  
The vendor for Motorola radio equipment is Pacific Wireless Communication, the authorized vendor for Motorola Radio Equipment is on the WSCA/SPO VL 05-13c22.
