

# STATE PROCUREMENT OFFICE NOTICE OF AND REQUEST FOR EXEMPTION FROM CHAPTER 103D, HRS

Pursuant to §103D-102(b)(4), HRS, and Chapter 3-120, HAR, the Department requests a procurement exemption to purchase the following:

3. Description of goods, services or construction:

Furnish labor, materials, equipment, and other expenses required to install in place complete a DOT-Harbors Division ductline across Ala Moana Boulevard at the Channel Street intersection to provide future security connections to the Federal Building. The work would be incorporated into the DOT-Highways Division project no. 92AB-01-06M - Nimitz Highway and Ala Moana Boulevard Resurfacing Fort Street to Piikoi Street that is currently under construction.

DOT-Harbors Oahu District certifies that funds are available through TRN 301 - Harbors Security.

8. Explanation describing how procurement by competitive means is either not practicable nor advantageous to the State:

Grace Pacific Corporation is the contractor for the Ala Moana Boulevard/Nimitz Highway Resurfacing Project for DOT-Highways. The project is currently in construction, therefore, DOT-Harbors needs to coordinate with Grace Pacific in an expedient manner to incorporate the revised contract drawings for the ductline into the DOT-Highways Ala Moana Boulevard trench crossing work to meet the existing DOT-Highways construction schedule.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable:

DOT-Highways has legally awarded the Construction Contract No. 54984 to Grace Pacific Corporation. DOT-Harbors will utilize the same rates and stipulations for the Harbors' work.

10. A description of the agency's internal controls and approval requirements for the exempted procurement:

The Harbors Engineering Maintenance Section is recommending the work with approval from the Engineering Program Manager, Harbors Oahu District Manager, Harbors Administrator, and Director of Transportation.


