

3. Name of Contractor: Various 4. P.E. Reference No. 08-081-C

5. Description of goods, services, or construction:
Provide twice a day, daily harbor tug services at Kahului Harbor, Maui, including labor, equipment, fuel and material for tug services to support Hawaii Superferry's (HSF's) loading and unloading vehicles, associated operations and monitoring of the soft line mooring system during ferry operations by holding the barge steady against the pier. Estimated tug services is 5 hours per day. Twice a day tug services to commence on May 9, 2008 to support HSF's second voyage to Maui.

6. Scope of work for the contract is revised as follows:
This is to amend previously approved amendment P.E. No. 08-081-C, dated 4/7/08, to include additional tug services every Sunday, Monday, Wednesday and Friday at Kahului Harbor, Maui to support HSF's second voyage to Kahului Harbor. Amended contract price is based on voyages in through June 2008. Services will continue to be solicited on a two week increment.
Original Contract Price: \$350,000 Amended Contract Price: \$750,000

7. Reason: This / These amendment(s) are necessary because:
HSF plans to commence two voyages per day every Sunday, Monday, Wednesday and Friday starting on May 9, 2008. HSF notified the DOT on 4/18/08 of the second voyage between Maui and Oahu. The tug service is necessary to comply with U. S. Coast Guard approved mooring plan as well as to ensure public health and safety are not compromised during the operations of HSF.
