Title and description of health and human service(s):	The service provides for an agency to develop policy recommendations for the State concerning a coordinated early childhood education and care system, which includes coordination strategies, resource development, and advocacy to promote the awareness and creation of activities that support the overall goal of young children being safe, healthy, and ready to learn. This service has also provided the State with research-based information on early childhood education and care, both nationally and locally; data about how our State compares to national trends; and facilitates partnerships between private organizations and public agencies to insure that the State continues to progress towards a coordinated system for young children.

Describe the circumstances justifying a restrictive purchase: The initial approval of the restrictive purchase of service was based on the fact that the Good Beginnings Alliance is recognized by the State Legislature and early childhood organizations and professionals within our State as the sole entity responsible for the coordination, facilitation, and monitoring of all early childhood education and care data, activities, and research for our State, as well as providing information about current research and relevant informatino from a national perspective to our State. This request is to allow the department to continue to contract with the Good Beginnings Alliance for a period not to exceed six months to ensure that the services continue to be provided while trying to competitively procure the services. As the Legislature did not renew the provisions of Act 77, allowing the extension of the restrictive purchase allows the Department to prepare a competitive RFP to determine whether there are any other organizations that may now be in a position to provide the requested service.

7. Describe the efforts and results in determining that this is the sole provider who can render services. Include approximate dates:

The initial approval for the restrictive purchase of service was based on the premise that the Good Beginnings Alliance is a statewide public/private partnership that aims to maximize healthy child development from before birth through the first eight years of life. First, by Executive Order, then by Act 77 of the 1997 State Legislature, the Good Beginnings Alliance was formally recognized as a statewide intermediary non-profit organization to spearhead efforts to create a coordinated early childhood system. The primary mission of the Good Beginnings Alliance is to authorize a sustainable, effective, participatory coordinating structure that cuts across existing social service systems to coordinate early childhood services for families with young children.
