For RFP No.: PSD 16-HCD-27, Mobile Dentistry Services for Correctional Facilities

Question No. 1: Question: Regarding the funding for the contract, the RFP indicates that funding will come from the FY2016 and FY 2017 state budgets. Since the first three months of this contract will take place during the FY 2015 period, how will the contract award recipients be reimbursed during that time period. This question has come up as we are completing the Proposal Application Identification Form (SPO-H-200), where in section 4 we have to indicate the funding request for each respective fiscal year of the contract. Are we to indicate 3 months of funding under FY 2015, 12 months under FY 2016 and 9 months under FY 2017?

Response No. 1: We will be encumbering funds for the twelve month period April 1, 2016 to March 31, 2017. The proposal should reflect the twelve month period.
