	2-22	The first sentence of this item shall be deleted and replaced to read as follows: <i>“Comply with Federal/State requirements for notification, or reporting of child abuse, child molestation, sexual abuse, rape, or incest and human trafficking.”</i> The second sentence of this item shall include: <i>“...domestic/intimate partner violence,...”</i>
