a. The unique features, characteristics, or capabilities of the goods, service or construction.

Pacific Wireless Communications is the only company in the State of Hawaii, certified by Motorola Inc., to repair Motorola P25 Digital radio equipment, ie., Astro P25 Digital Mobiles, Portables, Repeaters, Astro-Tac Comparators and associated miscellaneous equipment. Pacific Wireless Communication also has a C-15 contractors license which is required for work on our repeater stations, control stations and control points.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department to accomplish its work.

The Motorola Astro P25 Digital Radios are used to coordinate our day to day work and maintenance activities. The radios are also used during traffic control for construction projects, accidents and emergency situations that may arise on our highway system. The Radios are essential to providing communications during inclement weather and for recovery operations after inclement weather operations. It is vital to the safety of our workers and the general public the Motorola P25 Radio System be kept operational 24 hours a day 7 days a week.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction.

Pacific Wireless Communications is the only Authorized Factory Motorola Service Center in the State of Hawaii for the Motorola Astro P25 Digital radios we use in our Motorola Astro P25 Digital Radio system.

8. Alternate source. Describe the other possible sources for the goods, services, or construction that were investigated but did not meet the department's needs.

Other two-way radio providers were investigated but were not certified to sell or maintain Motorola Two-way Digital Radios.


