The goods, services, or construction has the following unique features, characteristics, or capabilities:

The Wang VS Computers and related equipment must be maintained by vendor-authorized and trained technicians capable of providing timely and efficient maintenance services to ensure its operation. Statewide maintenance requirements include but are not limited to:

1. Prompt response: two (2) hour on-site response for Oahu, Hawaii, Maui, and Kauai, four (4) hour response for Molokai and Lanai.
2. In order to effectively repair equipment, vendor must have a parts inventory on Oahu. All parts deemed critical must be maintained in inventory.
3. Vendor must have a minimum of three (3) years experience repairing Wang equipment.
4. Vendor must have a minimum of three (3) technicians to service agencies receiving 24 x 7 maintenance service.

REQUEST FOR SOLE SOURCE (Cont.)

How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

Operation of the Wang VS equipment is critical to ensure daily operation of State agencies utilizing the Wang VS. Currently, the Department of Agriculture and the Department of Hawaiian Home Lands utilize the Wang VS computer system.

The following other possible sources for the goods, services, or construction were investigated but do not meet our needs because:

Due to the proprietary nature of the Wang VS computers and related equipment, DigitalNet Government Solutions, LLC (formerly Getronics Government Solutions, LLC) is the only vendor capable of providing the required maintenance.
