Pursuant to HRS §103D-306 and HAR chapter 3-122, Subchapter 9, the Department requests sole source approval to purchase the following:

1. Describe the goods, services, or construction to be procured.
 Vidas Quality Control (QCV) kits, Vidas Salmonella kits, Vidas Ecoli O157 (including H7) kits, Vidas LIS, Vidas Listeria monocytogenes kits; Vidas Staphylococcal Enterotoxin II (SET 2) kits. Vidas is a high-throughput Immunoanalyzer that is used for the detection of foodborne pathogens such as Salmonella, E. coli O157, E. coli O157:H7, Listeria spp., Listeria monocytogenes, and Staphylococcal Enterotoxins in food samples.

6. Describe in detail the following:

a. The unique features, characteristics, or capabilities of the goods, service or construction.
 Vidas is one of the test methods that is recognized and accepted by the US FDA and the USDA because these methods have been validated and approved by the Association of Official Analytical Chemists (AOAC) for the detection of various pathogens (listed above) and is used widely by the food and agriculture industry.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department
 Identification of microbial pathogens most often implicated in foodborne outbreaks are of paramount importance. To accomplish this, the US FDA and the USDA engage public health laboratories through the Food Emergency Response Network (FERN) to perform targeted surveillance of food commodities (produce, processed foods and food products) to detect and confirm the presence of pathogens before these pathogens cause widespread foodborne outbreaks; to perform mitigation once the pathogen is detected by product recalls and/or performing trace back investigations to link the pathogens identified from clinical cases to the food or food products.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction.

The Vidas kits described in Section 1 can only be obtained from Biomerieux, Inc. and can only be used in the Vidas instrument. Further, the Vidas QCV kit can only be used for the Vidas instrument for quality control purposes to ensure that the analytical characteristics such as sensitivity, specificity, etc., of the kits as described above will perform as expected.

8. Alternate source. Describe the other possible sources for the goods, services, or construction that were investigated but did not meet the department's needs.

There is no alternate source.
