 Performing daily operations, the Highways Division, Oahu District, accumulates construction debris and materials. By EPA, DOH and FHWA requirements we are not allowed to stockpile these materials on our property which is under the freeway. These materials have to be taken to a landfill that has the required permits to accept all these types of materials.




