6. Describe in detail the following:
a. The unique features, characteristics, or capabilities of the goods, service or construction.
The Rainin Pipettors, Pipette Tips, and Accessories are currently used in the State Laboratories Division. The Rainin Pipettors are precision pipettors that are ergonomically designed for ease of use and minimal fatigue upon prolonged use and have demonstrated performance of precision accuracy of specimen and analyte delivery in critical assays requiring delivering very minute quantities of specimen or reagents.
b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department
The State Laboratories Division (Medical Microbiology Branch and the Biological Response Section of the Laboratory Preparedness and Response Program) already use Rainin Pipettors, Pipette Tips, and other accessories. These precision pipettors are primarily used for molecular biology procedures such as Real Time Polymerase Chain Reaction (rT-PCR) procedures for influenza, gene sequencing, other bacterial and viral assays. These procedures require precision pipettors capable of delivering very minute quantities of specimen or reagents. The Rainin pipettors are ergonomically designed precision pipettors that were selected for these procedures by the staff for ease of use and minimal fatigue upon prolonged use. These pipettors are assay dedicated and are used in specific steps in the various procedures. Dedicated assay pipettors are not intermingled with other pipettors or other assays to prevent cross contamination which can lead to erroneous test results. These pipettors are sent back every 6 months (or cleaned and calibrated annually) depending on the protocol to the manufacturer for servicing, calibration and repair in order to maintain their warranty. Rainin Instrument, LLC is the sole distributor for the Rainin pipettors, pipette tips, and accessories. See the attached letter.

- 6.b. How the unique features, characteristics, or capabilities of the goods, services, or construction are essential for the department (continued):

The Rainin pipette tips are manufactured specifically for use with these precision pipettors and have demonstrated to provide the best fit for accurate delivery of the specimens or reagents according to manufacturer specifications in our laboratory. Some generic brand pipette tips do not always fit as well on the pipettor which increase discard for improper fitting and delivery of analyte. Accessories can include such things as pipette racks for mounting the tips as well as replacement parts such as o-rings, grease, etc. which may be necessary following decontamination/cleaning procedures due to accidental contamination of the pipettor.

Rainin pipettors, pipette tips and accessories are manufactured and distributed solely through Rainin Instrument, LLC. See the attached letter from the manufacturer.

A previous Notice of Request for Exemption from HRS Chapter 103D, PE14-062B, approved with the CPO Comments that this is a sole source approval based on the department's representation that Rainin Instrument, LLC is the sole distributor for the Rainin pipettors, tips, and accessories.
