Pursuant to §103D-306, HRS, and Subchapter 9, Chapter 3-122, HAR, the Department requests sole source approval to purchase the following:

<p>Description of goods, services, or construction:</p> <p>Overnight express mail service for newborn dried blood specimens from 14 birthing facilities in Hawaii to the Oregon State Public Health Laboratory, which is Hawaii's contracted newborn screening testing laboratory in Portland, Oregon. Each year, the Newborn Metabolic Screening Program transports approximately 3,500 packages containing over 18,300 samples from almost every baby born in this state. These dried blood specimens and the accompanying patient information is time sensitive and confidential. It is important that these specimens not be delayed, misplaced, or lost. Timely screening tests performed on the blood specimens are essential to ensure early medical detection of thirty-one disorders that can cause mental and growth retardation, severe illness and even death, if not treated early in the newborn period.</p>

<p>The goods, services, or construction has the following unique features, characteristics, or capabilities:</p> <ol style="list-style-type: none"> 1. Only mail service with guaranteed overnight delivery from all the islands. 2. Provides tracking software so that the Newborn Metabolic Screening can track pick-ups and deliveries.

How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

1. The overnight delivery of the dried blood spot specimens to the newborn screening testing laboratory is essential to provide early diagnosis and treatment of newborns for thirty-one disorders which can cause mental and growth retardation, serious medical complications, and even death, if not detected and treated early in the newborn period.
2. Given the importance of the dried blood specimens, package tracking capabilities are essential to monitor transit times and locate the packages.

The following other possible sources for the goods, services, or construction were investigated but do not meet our needs because:

1. United Parcel Service: No overnight delivery available.
 2. U.S. Postal Service: No overnight delivery guaranteed. No tracking capability.
- Aero Couriers: No overnight delivery guaranteed since they depend on independent airline carriers. Do not have own tracking system. They track the packages based on the independent airline carriers. Do not have own nationwide personnel, delivery trucks, or planes. They use independent taxis to transport the packages from the birthing facilities to the airport and from the airport to the laboratory. Having multiple independent contractors increases the risk of losing a package and decreases assurances of confidentiality.


