This will be an annual recurring Request for Sole Source for maintenance to our Intergraph CADD systems.

How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:
 The Airports Division has used the Intergraph CADD systems for drafting, design, surveying, mapping and management since 1997. All contract plans and many forms of signs and presentation materials are created, modified and archived using the Intergraph CADD system.

The following other possible sources for the goods, services, or construction were investigated but do not meet our needs because:
 To our knowledge, no other vendor can provide or has the capability to provide the necessary services to maintain the Intergraph CADD systems at the level currently required. Support, maintenance, management and problem resolution is quicker and easier by having a single vendor for the Intergraph CADD systems.
