8. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities:

Pacific Wings is the only scheduled airlines flying into Kalaupapa Settlement.

9. Essential features. How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

Daily scheduled air flights between Honolulu and Kalaupapa are essential to getting patients and staff in and out of Kalaupapa for required medical appointments, meetings, and work.

Kalaupapa is a geographically isolated community on the island of Molokai that is only accessible by trail and air commuter. There are no roads into the Settlement. Barge service is available to Kalaupapa once a year. Air commuter service must be dependable with equipment that can accommodate an elderly patient population, average age 76, of which, 80% are disabled to some degree.

11. Alternate source. The following other possible sources for the good, service, or construction were investigated but do not meet our needs because:

There are no other scheduled passenger air carriers providing service to Kalaupapa.


