 Add to the existing scope of service the procurement and installation of required MEDICOM equipment to complete relocation of Med channels 1, 2, and 4 to the new site at Koko Head. In addition to receiving approval on S.S. No. 07-051-J for the expenditure of \$143,309.17 (FY 07) to be processed with a purchase order, the department requests approval for the expenditure of an additional \$42,122.15 (FY 08) on a second purchase order.

 Additional work is required. A new site was built at Koko Head to improve the inter-island microwave system. Relocating Med channel 2 from the old site at Koko Head to the new site at Koko Head and relocating Med channels 1 and 4 from Leahi Hospital will address site access issues and radio coverage problems for the makai side of Diamond Head.
