8. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities:
Pacific Wings is the only scheduled passenger airlines to provide services to Kalaupapa Settlement.

9. Essential features. How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:
Daily scheduled flights between Honolulu and Kalaupapa are essential in transporting patients and staff in and out of Kalaupapa for medical appointments, meetings and other business related activities.
Kalaupapa is a geographically isolated community on the island of Molokai that is only accessible by trail or air commuter. There are no roads into Kalaupapa. Barge service is available to Kalaupapa once a year, but the barge is only licensed to carry freight. Air commuter service must be dependable with equipment that can accommodate elderly patient population, average age 76, of which 85% are disabled to some degree.

11. Alternate source. The following other possible sources for the good, service, or construction were investigated but do not meet our needs because:

There are no other scheduled passenger air carriers that provide service to Kalaupapa.
