Qiagen Extraction kits for RNA, DNA, Blood DNA, RNeasy, One-Step Reverse Transcriptase (RT)- PCR (Polymerase Chain Reaction), Quantitect Probe RT-PCR kits, DNA PCR kits and other peripheral consumables and accessories.

8. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities:
Qiagen extraction kits, One-step RT (Reverse-Transcriptase)-PCR kits, Quantitect Probe RT-PCR kits, DNA PCR kits and consumables for DNA extraction and other peripheral accessories are used in the performance of manual nucleic acid extraction of microbial agents from clinical samples such as blood, stools, and from recovered bacterial isolates. Extraction kits are selected based on their performance characteristics such as sensitivity and their ability to overcome the inhibitory effects of some organic compounds in the clinical or environmental samples. Our validation studies showed that Qiagen extraction kits perform well and have consistently demonstrated good sensitivity. Moreover, since we are part of the National Laboratory Response Network (NLRN), we are required to perform standardized Qiagen extraction protocols by the CDC for the detection of BT agents to ensure that our results are comparable with other LRN labs.

9. Essential features. How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work: Molecular testing of clinical specimens ( human and animal), environmental, food and drinking water samples have been developed by National Reference Laboratories such as the CDC, NVSL and FDA for Public Health Laboratories. These molecular methods, such as the real-time (rti) PCR provide a rapid way to screen for microbial threat agents such as Human and Avian Flu virus, NoroVirus, B. pertussis/parapertussis, and a number of BT agents and toxins such as Ricin toxins. Qiagen extraction protocols provide a more sensitive and reliable way of extracting DNA or RNA from the sample. Given that molecular testing utilizes microliters of samples and considering that samples generally contain inhibitory substances, extreme sensitivity in extracting bacterial/viral nucleic acid is critical to ensure a good PCR assay. Additionally, National Reference Labs ( CDC, NVSL, FDA) have conducted numerous Multi-Lab Validation projects using Qiagen protocols and Qiagen has consistently demonstrated good performance characteristics in those validation.


