PSR activities promote socialization, recovery, self-advocacy, development of natural supports, maintenance of community living skills, including social and communication skills, and development of meaningful vocational opportunities.

6. Describe how procurement by competitive means is either not practicable or not advantageous to the State:
The Adult Mental Health Division (AMHD) released an RFP for PSR services on 6/30/09, with the Statement of Findings released on 9/23/09. The current PSR services was scheduled to end on 3/31/09, and was extended pursuant to the Hawaii Administrative Rules for Chapter 103F, section 3-149-301(c) through 9/30/09. On 10/1/09, AMHD received a Protest from one of the applicants who was not selected for an award. An extension of time will provide a continuity of services for our consumers while the AMHD goes through the Protest process, and new contracts are awarded.

7. Describe the reason for the selection of the provider including a description of how the procedure ensured the maximum fair and open competition practicable:
The identified Providers were applicants that were initially selected from the Competitive Procurement process completed in July 2002, which was a fair, open and competitive process.
