**Section 2, Service Specifications**

2.1 (E) 2-3 Change “Waianae/ 99-100” to “Waianae / 96-98 and 940002”

2.1 (F) 2-3 Change “Waianae/ 99-100” to “Waianae / 96-98 and 940002”

2.3 (C) 2-5 Please add “Multiple model proposals by two (2) applicants within a geographic region shall be allowed, provided there is one (1) primary applicant. The primary applicant shall be clearly identified. The DOH seeks assurances that the primary applicant shall be providing a minimum of twenty-five (25) percent of the contracted services. Subcontractors shall be identified and approved by MCHB after notice of statement of findings and decision. The total proposal amount for the multiple home visiting models shall not exceed the total funding amount allocated for the specific geographic region.”
