- 1. If you already had a Central Contractor Registration (CCR) number, will that number be automatically imported into the new System for Award Management (SAM) system?**

On the SAM website, the following information was posted regarding former CCR registrants: "If you had an active record in CCR, you have an active record in SAM. You do not need to do anything in SAM at this time, unless a change in your business circumstances requires updates to your Entity record(s) in order for you to be paid or to receive an award or you need to renew your Entity(s) prior to its expiration. SAM will send notifications to the registered user via email 60, 30, and 15 days prior to expiration of the Entity. To update or renew your Entity records(s) in SAM you will need to create a SAM User Account and link it to your migrated Entity records. Your CCR username will not work in SAM. You will need a new SAM User Account to register or update your entity records."

- 2. If the agency does not have any litigation pending do we need to include a statement as such or is there no need to include any statement?**

If the agency does not have any litigation, a statement should be included which so states.

- 3. What would happen to the set-aside amount if no proposals come in for culturally/linguistic-specific projects?**

The Office on Violence Against Women requires that all states and territories who receive Violence Against Women Act (VAWA) STOP funding must set aside at least 10% of the victim services allocation for culturally and linguistic-specific services. This is a mandatory provision under the VAWA 2005 reauthorization. If no proposals are received for culturally and linguistic-specific projects, the Department will re-solicit a new Request for Proposals in order seek projects who meet this federal requirement.
